I have been impressed and proud of how the staff and Board have adapted to continue this work throughout 2020.

This was also a big year for me in this work as I was elected as Co Vice-Chair of the International Living Future Institute and handed over the reins of Chair of the Living Future Institute of Australia to the extremely talented and passionate Tom Grosskopf.

When I took on the role of Chair I had a lot of reservations about my ability to contribute meaningfully. On reflection, we have made important progress. The thing for me to highlight is the "we". This is all of you reading this letter, the amazing staff led by Laura Hamilton-O'Hara, the dedicated Board, our volunteers, partners, sponsors and everyone else in the network.

AUSTRALIA'S FIRST CERTIFIED LIVING BUILDING



SUSTAINABLE BUILDINGS RESEARCH CENTRE (SBRC)

UNIVERSITY OF WOLLONGONG, NSW

The Sustainable Buildings Research Centre (SBRC) is the first development in Australia, and the third outside the USA, to achieve the Living Building Challenge®. As an organisation, the SBRC brings together students, researchers and industry to assist in the rapid decarbonisation of our built environment.

Once the funding for the project was established, it was decided that the design of the SBRC building needed to go well beyond the current Australian sustainability benchmarks for educational and other buildings.

The vision was that occupants, visitors and the general community could look back in years or decades to come, and know that the design of the SBRC stretched the boundaries of what was possible at the time of its design, and that this project represented a major

step forward in the delivery of highly sustainable buildings.

The LBC framework was a holistic way of approaching the challenge of delivering an outstandingly sustainable building, without being overly prescriptive and restricting the creativity of all involved.

The project Architects (Cox Architecture) worked closely with the SBRC/UOW leadership team to develop the concept design and coordinated the work of the many consultant groups involved.

This pioneering project was a huge team effort and has set the bar high for future LBC project teams. The legacy it leaves is definitive proof that the best is possible. Congratulations.

BURWOOD BRICKWORKS SHOPPING CENTRE

BURWOOD, VIC

Burwood Brickworks is aiming to become the first retail Living Building Challenge® development in the world. It is also the winning design in Australia's first Living Building Challenge® Design Competition in collaboration with Frasers Property Australia, who boldly went on to bring the ideas to life.

Burwood Brickworks opened to the public on Friday the 6th of December 2019. It has already won several major design awards including the 'Best of the Best' at the 2020 Architecture and Design Sustainability Awards.

The centre welcomes visitors to the great indoors with an urban rooftop farm and award-winning murals by local Wurundjeri-william artist Mandy Nicholson.

The project team also included over 200 reclaimed materials, including original

bricks that were made on-site when it was a functioning brickwork. These combine powerfully to give the building a rich sense of place and a unique story.

Burwood Brickworks is home to 46 retailers, including Woolworths, Dan Murphys, Reading Cinema and Ben & Jerry's; who each adapted their fit-out standards to meet the strict requirements of the LBC. What they learnt along the way has been applied to other stores around the country, expanding the impact of this project far beyond its site boundaries.

This community hub in the middle of suburbia is proving that an LBC project on such a large scale is possible, desirable, and transformative.

Congratulations to Frasers Property Australia and the entire development team.



Over two days, 117 participants took part in a virtual Wayapa session, heard from the likes of Google, Terrapin Bright Green and ASPECT Studios, and participated in panel sessions and workshops. The second day got practical, with a problemsolving team design sprint challenge. Teams had the choice of a playground design focused on culture and place or a social housing project that eliminated social stigma and showcased connection and belonging.

Thank you to all our speakers, the Biophilic Design Initiative panel and Rākeiora, Living Future New Zealand for your curation and hosting help, as well as Plunkett Street School and Metro Community Housing for providing the design challenges. Being online meant that we welcomed incredible speakers and guests from all over the world all with a very small carbon footprint!

The Oceania Biophilia Summit is an annual collaboration between the Living Future Institute of Australia and Rākeiora, Living Future New Zealand. In 2021, it will be held in Wellington NZ, which is a biophilic city.


